










This product's intended use is for added shelving space anywhere in home or office.






**STEP 1.** Start with poles (D) at the bottom (the foot (B) end). Snap two plastic sleeves (A) onto chrome poles at desired intervals for the basket (G). The sleeves are marked with a directional arrow to show proper placement. Use grooves on poles to ensure even placement among the four poles.

STEP 4. Determine if you are going to stack multiple shelves or use a single unit. If you stack multiple shelves screw the stacking screw (F) into the hole on the top of the four poles of assembled lower shelf unit. Before assembling top unit, take the feet off four poles and screw the poles onto lower shelf. Repeat steps 1 & 2 for top shelf unit. For the top unit screw plastic cap (E) into the holes on the top of the four poles.



STEP 2. Slide chrome poles (D) through basket corners until basket (G) rests firmly on sleeves. Push or gently tap the basket down at corners to level basket.

STEP 3. Repeat step one placing two more sleeves at the top side of each pole at desired intervals. Slide shelf (C) onto poles. Push or gently tap shelf down at corners to level shelf.
